**A RESOLUTION TO AMEND THE LOUISA COUNTY CODE, CHAPTER 66
SUBDIVISIONS AND CHAPTER 86 ZONING - DEFINITIONS (SINGLE-FAMILY
DWELLING, ATTACHED)**

**ORDINANCE AMENDING
ARTICLE I, CHAPTER 66, SECTION 66-2 and
ARTICLE II, CHAPTER 86, SECTION 86-2
"Definitions" Sections**

WHEREAS, Sections 15.2-1427 and 15.2-1433 of the Code of Virginia, 1950, as may be amended, enable a local governing body to adopt, amend, and codify ordinances or portions thereof;

WHEREAS Section 66-2 of the Louisa County Code was adopted in 1997; and

WHEREAS Section 86-2 of the Louisa County Code was adopted in 1989; and

WHEREAS since the adoption of these Ordinances, the Louisa County Board of Supervisors has, from time to time, amended them; and

WHEREAS the effect of this amendment shall constitute the same change to these two separate code sections; and

WHEREAS, notice of the Board of Supervisor's intention to amend these ordinances has been published in accordance with Va. Code Ann. §15.2-1427;

NOW THEREFORE BE IT ORDAINED that the Board of Supervisors of Louisa County, Virginia hereby amends and enacts Article I, Chapter 66, Section 66-2 of the Louisa County Code as follows:

Sec. 66.2. - Definitions

Single-family dwelling, attached. Two or more single family dwellings sharing ~~two~~ one or more common walls, each on its own individual lot. Attached dwellings are not vertically stacked.

BE IT FURTHER ORDAINED that the Board of Supervisors of Louisa County, Virginia hereby amends and enacts and amends and enacts Article II, Chapter 86, Section 86-2 as follows:

Sec. 86.2. - Definitions

Single-family dwelling, attached. Two or more single family dwellings sharing ~~two~~ one or more common walls, each on its own individual lot. Attached dwellings are not vertically stacked.


