Affordable Care Act, aka "Obamacare"

Goals

Affordable insurance coverage
Private insurance reform
Better health delivery system

In Virginia

One Million Uninsured Virginians
60% have incomes <200% FPL
75% are from families where someone works full or part-time

Coverage changes on January 1

State option for Medicaid Adult Coverage (no decision yet)
New Insurance Marketplace- affordable private coverage
People and businesses are required to have/provide insurance

New Insurance Marketplace

Federally Facilitated Marketplace (FFM)
To compare/purchase private health insurance
Qualified Health Plans (QHPs)
Premium Tax Credits only available with FFM plans

Also available to small employers
Fewer than 50 “full time equivalent” employees
Small Business Health Options Program “SHOP”

Eligibility Guidelines & Enrollment Process

Eligibility

Marketplace eligibility requires you to:

- Live in its service area
- Be a US citizen or national, or be a non-citizen who is lawfully present in the US for the entire time coverage is sought
- Not be incarcerated
- Not have access to affordable and adequate insurance

Application and Eligibility

- Submit streamlined application to the Marketplace (healthcare.gov)
- Verify and determine eligibility
- Eligible for Qualified Health Plan, Medicaid or CHIP
- Enroll in Marketplace Qualified Health Plan
- Enroll Medicaid/CHIP

Basic Eligibility for Marketplace Insurance with Premium Tax Credits

Income between 100%-400% federal poverty line

Family size	100% FPL	400% FPL
1	\$11,490	\$45,960
2	\$15,510	\$62,040
3	\$19,530	\$78,120
4	\$23,550	\$94,200

Not receiving or eligible for “minimum essential coverage:”

- Medicaid, FAMIS, Medicare
- “Affordable & Adequate” job-based coverage

Job-based coverage is not affordable/adequate if employee-only plan:

- Costs more than 9.5% family income; or
- Covers less than 60% costs

Open Enrollment

November 15, 2014-February 15, 2015

If enrolled by December 15, coverage can begin January 1, 2015

“Special Enrollment” after February 15 to enroll/change plan

- Loss of other coverage (except for non-payment, rescission)
- Birth, adoption, marriage
- Change in immigration status
- Error by FFM
- Other exception circumstances
