Call to Order, Quorum Established

Mr. Haymore declared a quorum present and called the meeting to order at 1:00 p.m.

Meeting Minutes Approval

Mr. Haymore made a motion for the approval of the February 5th, 2020 meeting minutes, seconded by Mr. Koegle. The motion was carried by unanimous vote of the Louisa Electoral Board.

Registrar's Report

Early Voting Site – The Louisa Art Center Gallery has been proposed as a possible location for the 2020 Presidential Election. Early Voting will commence 45 days prior to November 3rd, 2020. Discussion was held regarding the use of security seals on each precinct equipment cages.

Democratic Party Workers – A list of approved Election Officer workers has been received from the Democratic Party Chairman.

Republican Party Workers – A GR worker list discussion was held with the Louisa County Republican Committee Chairperson; awaiting response.

CyberSecurity Plan – The Louisa County CyberSecurity Plan extension has been extended to April 15th, 2020.

Legislative Update – No money increases have been approved by the Commonwealth Legislature for Electoral Boards, General Registrars, or voting localities.
